Where do I go for registration help?

Go to <http://weber.edu/register> for step-by-step instructions.

When is the tuition and fee deadline?

Tuition and fees are due by the Friday prior to the first day of classes.
Payment due by May 12 for classes beginning May 15
Payment due by June 9 for classes beginning June 12
Payment due by June 23 for classes beginning June 26
Payment due by July 7 for classes beginning July 10
Please remember that if your tuition and fees are not paid by the due date, you will be assessed a \$40 late payment fee and an interest charge of 1% per month.

How can I pay for college?

There are federal, state, and institutional monies to assist students in paying for college. Apply early to meet the priority deadlines for these funds. You can pay University expenses by credit card or check by logging into eWeber and clicking on "Tuition and Fees."

When do classes begin for summer term?

The first 4-week session begins May 15
The first 6-week session begins May 15
The first 12-week session begins May 15
The 8-week session begins June 12
The second 4-week session begins June 12
The second 6-week session begins June 26
The third 4-week session begins July 10

If I register for classes then decide not to attend summer term, do I have to pay tuition and fees?

Yes. It is your responsibility to drop all courses for which you are registered. You must pay for or drop your courses according to the summer 2006 refund schedule to avoid

paying for all or partial tuition and fees. To view the refund schedule go to <http://weber.edu/cashiers>.

Will there be a “purge” (or drop) process for any unpaid classes?

No! Courses will no longer be purged (dropped) for non-payment of tuition. When you register for a course you are reserving a seat in the class. It is your obligation to drop the course if you decide not to take it. Dropping allows other students access to the class. You must pay for or drop your courses according to the summer 2006 refund schedule to avoid paying for all or partial tuition and fees. To view the refund schedule go to <http://weber.edu/cashiers>. An official grade of “UW” will also be assigned to every class from which you fail to withdraw. A “UW” is a failing grade that is calculated in your GPA.

How do I totally withdraw from the summer term?

You cannot withdraw entirely using the on-line system. To withdraw from summer term, you must follow the dates listed on the Academic Calendar at <http://weber.edu/calendars>. You can withdraw in person at the WSU Registration window or by fax or email to the Registration Office. If you are receiving federal financial aid and want to withdraw from a class or from the entire semester, you must first contact the Financial Aid Office and speak to a financial aid counselor. Any withdrawal may affect your eligibility for future financial aid.

If I’m entitled to a refund, when will I get it?

Refunds will not be processed until the end of the final refund date based on the academic block you are attending. See the summer refund deadlines at <http://weber.edu/cashiers>. A "Record of Course Changes" form or "Total Withdrawal" form must be completed in order to process a refund or to reduce your tuition and fee assessment for dropped courses. These forms must be completed by the Registration Office. Please allow 4 to 5 weeks for your refund to be processed.

If I withdraw from an individual course or completely from summer term, what is the tuition refund schedule?

The tuition and fee refund schedule can be found at <http://weber.edu/cashiers>. A \$17.50 non-refundable fee will be assessed to all students who completely withdraw from the term.
