## **Engaging in Critical Dialogue**

Reflecting on the pandemic's ongoing toll on each of us and our Weber State students, please take the time to continue to reach out and personally connect with others. That personal interaction is critical to our well-being and belonging. Let's watch out for each other throughout this semester.

The need for this is magnified as we unpack last week's abhorrent and violent assault on the U.S. Capitol and what that says about the discord and fragility of our society. One of our primary roles as a university is to promote civic education, appropriate civic engagement, and critical thinking while often engaging in policy and ideological discourse. In these conversations, we focus on creating a common ground that fosters intentional listening.

#### **Legislative Information**

As of today, our state financial forecast looks promising. We anticipate a 3% salary increase for state and higher education employees but will know more information when the final budget is passed. While there has been no talk of restoring cuts, we do not expect additional cuts at this time.

At the federal level, we are waiting for additional guidance from the Department of Education regarding how new stimulus funds will impact higher education, but we anticipate being able to continue to offer additional pandemic aid to our students and receive another infusion to help the university address financial impacts from the pandemic.

#### **Enrollment**

As of last Friday, our spring enrollment is down 1.5%, which is a positive gain from prior weeks. This would not have happened without the support of many individuals across our campuses. Thank you to those who accommodated waitlists by adding additional sections, finding instructors for additional sections, and teaching those. Thanks also to our advisors for reaching out to students, to the efforts of our financial aid office, and thank you to all of you for fostering an environment to help our students feel welcome at Weber State. Please continue to connect with students especially during these first few weeks of the semester. Our personal connections with students are what make Weber State unique.

# **Testing and Vaccinations**

# **Testing**

- Entry testing will be available Jan. 4–22, 2021 for on-campus students, faculty, and staff. Testing continues to be available to any member of our community, even if you don't regularly come to campus. You can sign up for a test using the COVID <u>testing form</u>. After January 22, we will be emailing randomly selected on-campus individuals to be tested as we continue to monitor COVID on our campuses.
- We still want all individuals to self-report if they have tested positive for COVID.
  Individuals with symptoms can be tested at our <u>symptomatic site</u> in the Marriott Allied Health Building.
- Information on our current testing numbers can be found on our <u>COVID website</u>.

#### Vaccinations

- Weber Morgan Health Department is currently providing vaccines at the Dee Events Center through a collaborative effort with Weber State.
- While we are assisting in the administration of vaccines, we do not have control over the timelines or availability of vaccines.
- As of today, the current guidance prioritizing teachers does not include higher education institutions.
- We are working to secure our Closed Point of Dispensing (POD) to be able to administer vaccinations to faculty and staff but do not have information regarding that yet, and we do not know when vaccines will be available to order for our POD based on the federal and state prioritization guidelines.
- The guidance and availability of vaccines is changing on an almost daily basis, and we are in regular conversations with the Weber Morgan Health Department regarding what this means for our students, faculty and staff. We will share vaccine updates for our campus community as soon as additional information is available.
