Vice President for Student Affairs, Weber State University, March 2018-Present

Provide strategic vision, direction, and leadership for an open enrollment university of 30,000 students in Northern Utah. Lead a comprehensive division of student affairs with a diverse array of more than 30 departments with more than 180 staff offering programs and services for students and the university community. Coordinate fiscal responsibilities of approximately \$40M. Work across multiple campuses in a complex and dynamic environment to support student success by establishing and maintaining positive relationships among constituents. Responsible for policy development, strategic planning, and the successful implementation and evaluation of essential programs and services for student and institutional success. Synergize with community leaders, Trustees and Regents, and other critical stakeholders to anticipate needs and innovate solutions to major challenges facing a changing demographic of students and the university.
