3. If this is a paid experience, Student should be listed as an employee of the Organization and complete the usual employment forms. Student will be covered by Organization's insurance including workers compensation. Organization and Student shall agree upon how Student will be paid. All payment matters are subject to agreement between Organization and Student, Weber State University will not be involved with any employment matters and Student agrees to release and hold harmless Weber State University from all matters related to their employment by Organization.
