1. <u>TLF Strategic Planning</u> Update – Colleen Packer

A program review of TLF is being done February 25-26, 2019. This will review TLF's 1) programs and services, 2) resource allocation and 3) infrastructure and organizational structure, in an effort to clarify directions for strategic planning. It was suggested that a student be added to the stakeholders for their unique perspective. Because the TLF director is chosen by Faculty Senate they should be included in the program review.

All interdisciplinary/high impact programs are being set up for program reviews but they are not set up to be reviewed by EC since they are not specifically academic programs. The results of these reviews will come to EC.

Academic Affairs Goals and Program Responsibilities – Madonne Miner, Provost
 Update of Academic Planning task force. Want to approach planning from the grass roots of programs and then the Office of the Provost will give commentary on those ideas.

Funding from a retiring professor used to be entirely retained by the college. This does not allow for areas that are growing to receive additional funds. A policy has been implemented that allows the college to retain the amount of an assistant professor. Twenty five percent of the remaining money went

back to the Provost office. This coming year it will increase to 50%. The deans have been supportive of this and it has worked well for them. They voted on which new faculty positions should receive the funding and the results were quite consistent within the group.

The new Strategic Analysis Report (end of year report that colleges will be generating) will be used as a basis for what will be happening in the future within the college. The final report is due in May, information will be out in early Spring. Think about the value that your program is providing to the institution, efficiencies that you are operating with and how are you contributing to student growth.

- 3. Curriculog Approvals for Department and Org Change– Patti Glover Proposal for department name changes and organizational changes have come regularly to Executive Committee and they have decided if they are information items or action items for Faculty Senate. Now that these proposals are tracked through Curriculog an item will be added to the proposal history section in Curriculog for the Faculty Senate. This will be set up as a notification, not an approval step. EC will continue to determine if these are informational or action items at senate.
- 4. Department and Org Changes EC Jan 10, 2019 Non-Curriculum Valerie Herzog
 - a. ATN & HPHP Department Reorganization The reorganization of the AT programs is being done to be in compliance with the accrediting body for Athletic Training. Will be official July 1, 2019
 - b. New Department of Exercise & Nutrition Science This came up because ATN is changing colleges.
 - c. Jerry and Vickie Moyes (AT move to Health Professions and new Department Name)

These proposals will move to Faculty Senate as informational items

- 5. New Centers EC Jan 10, 2019 Non-Curriculum Madonne Miner, Provost
 - a. Matthew Browning Center for Design This is an interdisciplinary and inter-college project-based learning center focused on different forms of design. This will be housed under Arts & Humanities. Initially this will be headed by faculty in A&H but it could change in the future.
 - b. Wadman Center for Excellence in Construction & Building Science
 This center allows various EAST departments to come together, allowing co-curricular activities to come to fruition. Will primarily be used with Construction and Building Sciences departments.

 New centers are action items for faculty senate.
- 6. Program Discontinuance Doris Geide-Stevenson EC Jan 10, 2019 Non-Curriculum
 - a. Economics (BS) Quantitative Economics Emphasis
 - b. Economics (BS) International Economics Emphasis
 - c. Economics (BS) –Economics with Legal Studies Emphasis
 These are becoming stand-alone majors so no programs are being discontinued.

- 7. Ombuds Position Doris Geide-Stevenson
