4. Textbook Subscription Model- Sarah Tooker, Chaz Steimel, Ashley Hinton

The collection of data was started in 2021 and the analysis of the outcomes of the surveys. The goal for today is to share information about the textbook subscription model. Presenting to the Faculty Senate is one of the steps to make sure that we share with all the stakeholders. The Open Educational Resources (OER) is included in the student list. There are a few key things out of The

Faculty Watch survey that was last sent out in November. 50% of faculty did not update their books, 29% of faculty did not know what the cost of the book was, and about 51% did not understand affordability. Shared the Textbook Cost Dashboard that is prioritized for gen eds. The different types of adoption are listed in the data. This is only one year's worth of data and the data is 85-90% good. Should have access to this data and we will continue to build out the database and want to share it out to departments. The goal is to make this transparent. The faculty are still asked to add the texts that are being used. Can add anything that is being used on the booklist including links to websites and this will make it clearer for students.

The accuracy is what the bookstore would like to see more accuracy for students. Would like to see if we can help to decrease costs for students. The textbook manager can work with a publisher to pull the chapter or sections from a text to save money. Equitable access is the direction that the bookstore is going and would like to become more of an academic service and try to find the most cost savings for students. The cost for the Textbook Subscription Model was determined by consulting with Milliman and using an actuary to come up with a cost. 12 credit hours \$18.80 per credit if it's universal and \$21.20 per credit if it's opted out. Trying to keep them as low as possible. Would need faculty buy-in for the model to work and the information will be shared with the Faculty Senate and ASSA. Discussion on the opt out model and if students will understand what this would mean. This would start in Summer 2025 and would be included in the orientation process. It is a linear cost per credit hour. There will be a default effect and as the process goes along that people will choose the default, that could become an issue and simplify their lives. President's council will make the vote in March to get the go ahead. Suggestion to tighten up the presentation for the Faculty Senate then return in March for EC and then FS.

This is coming out of the Graduate council and has been approved by the presidents council. Essentially before graduate programs can put through a proposal they would have to put together the big picture of what it would be used for and what the employment outlook is. It will also address

the sustainability of the programs. This endorsement will be before the regular curriculum processes.

After it has been approved to move forward for endorsement, then they go to the Provost's office, and then it will move through the curriculum. The Graduate Studies office will provide a letter of the process. Will not change the curriculum process. There are 40 graduate programs or certificates.

It needs to be looked at by other entities on campus, not just the Faculty Senate. There needs to be a mission statement and more buy in. Come up with a recommendation for the request and the reasons why. Also feel like they are represented in the Faculty Senate.

10. Travel funds availability and how faculty can complete there expectation of scholarship if there is

no money to travel- Ryan Cain

There are concerns about how the funds are allocated and how it can affect tenure track faculty. Discussion on getting more travel funds for travel due to cost increases. Would like to express this in the end of year report about the need for more travel funds. Every department or college has a different system of distribution of funding. Ravi Krovi asked if Ryan Cain would come to speak on this issue.

The chair of TLC was asked to consider a concern about admission standards regarding language standards. There was a question on the use of Chat GPT and standards for language standards. There is an Al task force and have had some international students coming late to courses and also have tried to have the work translated to their language. The need for more onboarding for international students and the guidance.

12. OUR- Mary Beth Willard

Discussion on the Office of Undergraduate Research (OUR) and some faculty members approached FS reps and there are faculty that take students to conferences and it has increased over the years. The ask is if OUR can have a rubric and how can we make sure that students are able to apply for funds. The application can be onerous if its been for projects it has been better but travel has been hard. Would like transparency in the process. Discussions on the problem. Recommended that it would be good to speak with them. But the Faculty Senate does not have a say.

Program discontinuances are coming through there are three with five separate proposals.

The BOT schedule to make sure to get the presentation and title to Sherri Cox.

Discussion on HB 438. It will be discussed next week. There is language that is very specific and some that is very vague. Waiting to see how discussion goes and this is up for modification. There is a push to make modifications to this bill. Feeling is that it will affect the ability to attract new faculty because of this bill.

Will be discussing the diversity and the legislature's approval of the language and definition of what will happen. We are doing a search for a vice provost to replace Eric Amsel. The Provost is thinking that the person hired will take some of this over. The provost's office is thinking about how the functions will be parsed out and still continue to support the students; it will not be dealt with immediately. Question: Will this affect students that apply for grants that target specific students? Probably will not because it is federally funded. But this is not confirmed. Wondering about the EDI attribute in gen ed. The bill is vague in the language and will be taking a look at things closely after the close of the legislature. Should not impact curriculum. There was no consultation with higher ed and there will be some back and forth.
