International Student Graduate Admissions PPM 11-1 3.23, 3.25- Conrad Gabler

The change was made to consolidate the language into one area and make it available in one location. They cleaned up the international student admissions language testing options. To make it easier for advisors and students to accept different tests than have been in the PPM. Discussion if other tests are accepted at other schools and comparing thresholds to make sure we are aligning with other institutions in Utah. Also tried not to make the language too structured and allow the flexibility to change as testing evolves. # Membership recommendation

Concurrent enrollment is a large concern for enrollments and for the HSI designation. Faculty have expressed some concerns about what is being taught and who is running the concurrent enrollment. Also who is teaching and what curriculum is being used. In addition, the committee would be a reporting channel for faculty. The recommended people are individuals that are involved in the different areas of concurrent enrollment. Would like to have an ad hoc committee. Jason expressed concerns about how it was recommended and how the committee is formed. Mary Beth questioned if this should be a faculty senate committee or if it should be a task force. Would like to see one representative per college. Hal I think it is symbolic that it is a faculty concern. Michele What would the committee do? Hal the reporting structure comes from Jessica and touches on Eric's side. The actual academic content is an Academic Affairs concern. Mark Denniston stated that ASSA is going to bring something like this forward and is thinking of what the charges would look like. Need a body that will need more expertise in concurrent enrollment. What is the consistency across departments?

Ravi Supports Hal on the need for more . Does it need to be a FS committee? Hal- the way that we have been thinking about it is that general education has its own committee and feel that there needs to be a support for concurrent enrollment. The feeling is that if WSU has a strong concurrent enrollment program to allow students to want to continue at WSU. Would there be any authority and recommendations? Sarah-Feel like it would be useful to have a committee. Mary Beth- feels like it would be an ASSA charge. Discussion on ad hoc and how it is created and the intention of what it would be. Also would allow concurrent enrollment.

Discussion on if it belongs in the Faculty Senate.

Discussion on the poll Mark doesn't feel that a poll would help. Maybe it's a charge to ASSA to find out what the need is for the issues at the university.

# 7. GEAIC charge on the new general Education legislation- Mary Beth Willard

This is a charge to look at the new general education change from USHE. It has been changed from 27-30. Would like a formal charge to look at what the tenth class would look like. The new requirement says that institutions can have between 27-30 credits, where 27 of the credits are in the core/breadth areas. Weber needs to figure out a) whether we want 3 more credits (so far gen ed council/Eric thinks this is probably prudent) and b) what a three-credit option might look like (such as a required freshman seminar, or a FYE class, or some other option). Discussion on what it will look like, what are the options to fit into the space and also looking at a way to make it meaningful. Added does it affect transfer students. Investigate adding up to three more credits in General education and if so what those options should be and what are the possibilities.

Action: come to the conclusion of what the charge will say to allow flexibility. Wording will be approved via email.
