For inclusion of course and program proposals in the 2024-25 University Catalog, items will need to be passed by the Curriculum Committee at the **January 9, 2024\*** meeting  
and then passed by the Faculty Senate at the **February 8, 2024\*\*** meeting.

All new and substantive course and program proposals must be passed by the UCC January meeting to be offered and included in the upcoming year's catalog and class schedule. Nonsubstantive proposals must be on the UCC Chair step by the end of February (and approved) to be included in the upcoming year's catalog.

**New courses at all degree levels** that are requesting course fees must submit a Curriculog New Course Fee proposal. Courses not so identified will be ineligible to propose course fees for 3 years.

**New program proposals** must be approved by President's Council and Board of Trustees before they can be included in the University Catalog. Allow *at least six weeks* from the time the proposal is approved by Faculty Senate for it to go through President's Council and Board of Trustees. Additional approval is required from NWCCU before students may be recruited to a new program or financial aid can be given to students enrolled in the program. Another 2 - 3 months is required for NWCCU approval after approval by the Board of Trustees. Proposing a new major or emphasis requires completing a *full* R401 template which should be uploaded to the Curriculog program proposal.
